Thanks to your support the Staten Island Museum reached the following milestones during 2009:

- Our flagship Museum in St. George, located just two blocks from the Ferry, experienced an amazing **57% increase** in admissions, despite the recession!
- We conserved an historic, 6-foot tall canvas underwater diver’s suit that is now starring in our Staten Island Ferry exhibit.
- We renovated and moved our *History Archives & Library*, which is now easily accessible on the first floor of Building H, underneath the Art Lab, on the Snug Harbor campus.
- Joining the celebrations of the 400<sup>th</sup> Anniversary of Henry Hudson’s discovery of the river, we created *CONTACT: 1609*, a highly publicized exhibition of seven contemporary artists interpreting the encounter between Hudson’s expedition and the native Lenape tribe.
- We have published a gorgeous and informative trail guide of the *William T. Davis Wildlife Refuge*, named after our co-founder.
- In June 2010, we will break ground for the renovation of Building A on the Snug Harbor campus!
